NOTICE OF ADOPTION OF BOND
RESOLUTION

NOTICE IS HEREBY GIVEN that the Pennsylvania Intergovernmental Cooperation Authority (the "Authority") adopted a resolution on May 5, 2009 (the "Resolution") authorizing the issuance by the Authority of its Special Tax Revenue Refunding Bonds (City of Philadelphia Funding Program) Series of 2009 (the "2009 Bonds") for the purpose of refunding the Authority's Special Tax Revenue Refunding Bonds (City of Philadelphia Funding Program) Series of 1999 and paying certain other costs and expenses (including, potentially, costs of terminating certain interest rate hedge agreements entered into by the Authority) relating to such refunding. Pursuant to Section 803(b) of the Pennsylvania Intergovernmental Cooperation Authority Act for Cities of the First Class (the Act of June 5, 1991, P.L. 9, No. 6, as amended), you are hereby notified that:

1. The Resolution was adopted by the Authority on May 5, 2009.
2. A copy of the Resolution has been filed for public inspection at the office of the Authority at 1500 Walnut Street, 16th Floor, Philadelphia, Pennsylvania 19102, and at the office of the Chief Clerk of the City Council of the City of Philadelphia (the "City") at Room 402, City Hall, Philadelphia, Pennsylvania 19107.
3. This notice is published on May 11, 2009.
4. Any action or proceeding of any kind or nature in any court questioning the validity or proper authorization of the 2009 Bonds provided for by the Resolution, or the validity of any covenants, agreements or contract provided for by the Resolution, shall be commenced within 10 days after the publication of this notice.

If no action or proceeding questioning the validity or proper authorization of the 2009 Bonds provided for by the Resolution, or the validity of any covenants, agreements or contract provided by the Resolution, shall be commenced within 10 days after the publication of this notice, then all residents, taxpayers and owners of property in the City and all other persons whatsoever shall be forever barred and foreclosed from instituting or commencing any action or proceeding in any court, or pleading any defense to any action or proceedings, questioning the validity or proper authorization of the 2009 Bonds, or the validity of any such covenants, agreements and contracts, and the 2009 Bonds and such covenants, agreements and contracts shall be conclusively deemed to be valid and binding obligations in accordance with their terms and tenor.
